## Entry Level Required Qualifications (By Date of Hire)

- Must be 21 years of age or older
- Must be a citizen of the United States, or eligible to hold employment in the United States.
- Must be able to read, write and speak effectively in English.
- Valid WASHINGTON State Drivers License
- High School Graduate/GED or equivalent.
- Current National Registry or WA State certified EMT-B. (Successful completion of Thurston County EMT Protocol Test within 30 days of appointment.)
- IFSAC Firefighter I

## Additional Lateral Requirements

- At least one (Two) years of current, uninterrupted service working as a Career FF/EMT.

## Desired Qualifications

- College preferred but not required
- Candidates encouraged to apply without possessing desired qualifications
- ICS 100, 200 & 700
- NWCG FF II (Wildland Red Card) (required within one year of appointment)

## Disqualifiers:

- Criminal Activity, candidates must pass criminal background investigation
- Driving candidates must pass driving record evaluation
- Drug Use candidates must pass drug screening. Illegal drug use or exposure within 3 years.
- Lying or falsifying documents during any stage of the hiring process. Dishonorable discharge from United States armed forces.

Applicants must submit a cover letter, completed application, resume, copies of applicable Fire/EMS certifications, a current NTN score, and a CPAT completion certificate.
